# DOMESTIC RULES OF THE SCHOEMANSVILLE OEWERKLUB

(Revision approved on 19 September 2017)

All Club members and visitors entering the premises, by doing so, submit themselves to the rules of the Club. Visitors who break the rules may be summarily requested to leave the premises.

1. The Club is situated in a residential area and there is a limit on the acceptable sound levels. No open air sound systems are permitted on the site and no music may be played at levels that constitute a nuisance to residents.
2. Each person who enters the Club's premises and uses the facilities or equipment does so entirely at his/her own risk. Neither the Club, nor its management, accepts any responsibility for any losses suffered for any reason whatsoever.
3. Busses and vehicles used for public transport, trailers and other vehicles may only park on spaces allocated for this purpose.
4. Visitors are not allowed to park on places reserved for Club members.
5. The speed limit on the site is 10km/h.
6. Only existing roads may be used and vehicles may not be driven in a way constituting a danger to people or animals.
7. Fires are only permitted in the appropriate fireplaces and must be extinguished before leaving the site.
8. Rubbish may only be disposed of in the appropriate containers.
9. Nobody is allowed to damage or misuse any lawns, trees or any other plants or any property of the Club.
10. Nobody is allowed to do anything or use any equipment in such a way that it constitutes a nuisance or danger to humans or animals.
11. Birdlife may not be disturbed in any way.
12. Nobody is allowed to -
  - i. Collect money from the public
  - ii. Offer any public entertainment or have a meeting
  - iii. Conduct business for own profit without the consent of the Committee.
13. No vehicle or craft without silencers are allowed on the site.
14. No motorised craft are allowed in the angling area.
15. No angling is allowed in the boating area.
16. The person leasing the lapa or clubhouse accepts full responsibility for the building and equipment, as well as the conduct of their guests. A refundable compliance deposit is payable which may be forfeited, in part or in full, if justified complaints have been received about the conduct of guests or noise levels, if the facility is left in an unacceptable or damaged condition or if the time booked is exceeded.
17. Members are allowed to bring guests on the following conditions:
  - i. The number of guests is limited to six excluding the member's family members;
  - ii. All guests must be signed in;
  - iii. The member must spend the time with his/her guests;
  - iv. The member accepts full responsibility for the conduct of his/her guests.
18. Pets must always be under full control.
19. All suggestions and complaints must be submitted to the Management.
20. Anybody breaking or failing to heed these rules may be liable to disciplinary steps which may include expulsion from the premises or, in the case of members, the temporary or permanent suspension of membership privileges.
21. For visitors the gate closes at 15:00 and they must vacate the premises by 18:00.
